RESOLUTION TO AMEND APPLICATION AND LICENSE FEES FOR MEDICAL MARIJUANA LICENSES

WHEREAS, on pursuant to the authority granted in C.R.S. 44-10-104, the Board of County Commissioners (“Board”) has adopted the El Paso County Medical Marijuana Policy for the licensing of medical marijuana facilities in unincorporated El Paso County; and

WHEREAS, C.R.S. 44-10-302 authorizes the Board, as the local licensing authority, to collect fees for and issue the following types of local licenses: medical marijuana center licenses, optional premises cultivation licenses and medical marijuana-infused products manufacturing licenses; and

WHEREAS, the Board finds it necessary to update the application fees previously established to reflect the actual expenses incurred by the County in processing each application type; and

WHEREAS, the Board further finds that the application and license fees set forth below are in the best interest of the public health, safety and welfare.

WHEREAS, both the Permanent Medical Marijuana Rules and the Colorado Revised Statutes have been amended since adoption of Resolution 12-255, and it is now necessary to update the El Paso County Medical Marijuana Fee Schedule.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of El Paso County, Colorado that following application and annual license fees are hereby adopted and will become effective immediately.

Medical Marijuana Products Manufacturing	\$1800
Medical Marijuana Cultivation Facility Class 1 (1-500 plants)	\$1800
Medical Marijuana Cultivation Facility Class 2 (501-1500 plants)	\$800 (\$1800 + 800 = \$2600)
Medical Marijuana Cultivation Facility Class 3 (1501-3000 plants)	\$2000(\$1800 + \$2000 = \$3800)
(Expanded Plant Count Class 3+ (3001+ increments of 3000 plants)	\$800 per add'l 3000+ plants
(\$1800+\$2000+\$800 per add'l 3000+ plants
